### **SCHOLARSHIPS**

**Active Duty, separated, and retired SOF and their families** 

"The Special Operations Association Foundation provides educational grants to vetted Active Duty, separated, and retired SOF and their families through the SOA's George C. Morton Memorial Scholarship Program." The SOAF provides education grants to vetted Active Duty, separated, and retired SOF and their families through the George C. Morton Memorial Scholarship Program. As of August 2018, 163 young men and women have been awarded a scholarship since the commencement of the program in 1983. The George C. Morton Memorial Scholarship Grant is awarded by the Special Operations Association (SOA) and must be used at an accredited Junior College, Community College, Technical school, or Four-year college or university for studies which will lead to an Associate Degree, a Bachelor's Degree, or a technical vocational program certificate.



**ELIGIBILITY:** A high school graduate, or a high school student anticipating graduation during the year of application, unmarried, and under the age of 21 years at the time of application. Must be a son, daughter, or grandchild, natural or adopted, of an individual who served in a Special Operations unit, and is a SOA member in "good standing". Applications are also accepted from wives and widows of Special Operators who are members of the Special Operations. Association or were KIA or MIA while serving with a Special Operations unit in combat.

**APPLICATIONS:** Application packets are available from 15 September of the previous year to 15 February of the year that the grant will be awarded. The deadline for the submission of all formal applications is 15 April of the year the Grant will be awarded. # SOA FACT SHEET

The SOA, established in December 1977 is a fraternal veteran's organization of past and present American and Allied military personnel who have conducted special operations in a combat environment. The group includes veterans from World War II, Korea, Vietnam, Panama, Grenada, the Balkans, Somalia as well as those from our most recent conflicts in Afghanistan and Iraq. Membership is limited to Free World forces who supported, or personally participated in missions deep inside hostile territory in a combat capacity.

For the most part, the SOA is composed of U.S. Army Special Forces personnel but, also includes USAF Air Commandos/FAC's, Navy Seals, Marine Raider, and Force Recon personnel and veterans of other elite military organizations who were an integral part of Special Operations.

The specific and primary purposes of the SOA are:

- a. To unite fraternally all veterans who have or are now conducting or supporting classified "Special Operations" deep in hostile enemy territory or have been assigned to military units which conducted such operations; and,
- b. To perpetuate the Special Operations "esprit de corps"; and,
- c. To commemorate fittingly the memory of those who have given their lives in defense of the Free World and to those who served in Special Operations units and are still unaccounted for as POW/MIA through the management of the SOA George C. Morton Memorial Scholarship Grant Fund. Since 1983, over \$648,500 has been awarded, or committed thus far to 163 deserving young scholars.

The Special Operations Association is recognized by the Department of Defense and by the IRS as a non-profit veterans organization, 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). Annual membership dues are \$30 U.S. Lifetime membership fee is \$505 U.S. 70-years or over, Lifetime fees are \$305. U.S. The organization has no meetings other than its annual reunion. The primary organizational correspondence is the Pre-Reunion Packet (PRP) and the Special Operations Association Reunion After-Action Report, (SOAR AAR).

The SOA conducted its 42d annual reunion (SOAR XLII) in Las Vegas, Nevada at the Orleans Hotel and Casino during the period 15-19 October 2018. This year's attendance was 674 members and guests. Honored during a Memorial Breakfast were family members of 11 of the 16 fallen warriors at FOB 4.

### **FOB Memorial Breakfast**



#### Remembrance 23 Aug 68 Memorial Breakfast

On October 17, 2018, the Special Operations Association proudly hosted a Memorial Breakfast at our Annual Reunion to honor the 16 families who lost Special Forces MACVSOG heroes at FOB 4, CCN, Marble Mountain, Danang, Republic of Vietnam on 23 Aug 68. Due to the outstanding support of the SOA and its Board, as well as the thousands of hours of work by the 23 Aug 68 Memorial Committee, the Breakfast was an outstanding success throughout the SOA community.

Due to the Top Secret classification of MACVSOG, none of the families were familiar with the service of their fallen ones. Few outside SOG were aware of the horrific casualties of CCN/SOG in 1968. Combining WIA, MIA and KIA, CCN casualties exceeded 100%. Neither did the families know of the early morning attack that killed their loved ones and led to the award of 66 Purple Hearts.

Over 320 guests and members attended the breakfast. Approximately 52 members of the families attended. Unknown to the Committee, 6 Medal of Honor recipients were in the audience. As the families and guests were seated, a streaming video of all 16 fallen was shown. The video was created by Bonnie Cooper. Bonnie, a distinguished US Army retiree, "found" our Committee through her husband, a retired SF trooper. Her contributions to this Breakfast, including contacting the families with Steve Bric, brother of KIA Bill Bric, were critical to our success. The families were especially grateful to her for her support in notifying them of the event and assisting them in getting to Las Vegas.

An additional video was given to us by Eldon Bargewell. "Angel Flight" was edited by Bonnie and streamed as well.

Our Chaplain, Doc Padgett, delivered a beautiful prayer to open the Memorial, which is, by the request of many, reprinted below.



One of the most memorable events of the 23 Aug 68 Memorial Breakfast was a presentation by Dan Thompson, MACVSOG veteran. Dan presented the "Ceremony of Ashes and Names" (of the fallen heroes) accompanied by a slideshow. Dan first performed this ceremony inside Marble Mountain in the Buddhist Temple with the assistance of a Buddhist priest in the '90s. With some family members and survivors present, he replicated the ceremony this year at The Wall in Washington D.C. on the fiftieth anniversary of our horrible day.



The names of the fallen are written down, then the paper is burned to ashes. The names were called out and memorialized by the ringing of a bell cast in Vietnam. After taps played, the ashes and mementos from the families were placed in a memento box prepared by Bonnie. Included was sand from Marble Mountain.



The box was placed at Panel 47, West Wall, by Dan and Doug and collected by The Wall staff for placement in its permanent collection.



The families were contacted and organized for travel to Vegas by Bonnie and Steve. They were met at the breakfast by a committee of greeters, and given handsome corsages designed and crafted by sweet survivor and Marble Mountain hero Larry Trimble. Larry and his team spent several days before and after 23 Aug 68 suppressing not only the 23 Aug 68 attack, but several more on his own team. Larry also prepared badges for the survivors so that they and the families could identify each other.



Each family was called to the dais. As they approached, a biography of their loved one was read. In addition, the Bronze Star w/V award citations for Bill Bric and Robert Uyesaka were also read.

Each family received one or more FOB plaques, identical to the plaques SOG recon men received as they left country. The plaques and metal work were prepared by Committee members Gene Pugh (survivor) and Bruce Christensen (son of a survivor).

Every family member and breakfast attendee received a 23 Aug 68 challenge coin designed by Bruce Christensen, also an SOA historian.

The plaques and medals were presented to the families by legendary MACVSOG recon men, CSM Spider Parks (also a survivor) and Major General Eldon Bargewell.

After a concluding prayer, accompanied by many glistening eyes, we adjourned. We were fortunate to elicit the interest of the Stars and Stripes Newspaper. Reporter Diane Cahn followed up with a terrific article, which is on the SOA website. Chapter 78 of the SFA also published an article by Bonnie Cooper on our memorial.

On a personal note, I have rarely served with such enthusiastic and selfless volunteers as Bonnie, Steve, Gene, Larry, Bruce, Dan, Rick, Spider, and Eldon. Thanks also to the Special Forces Charitable Trust for its support.

Last, blessings and prayers to our lost comrades and their families.

Army/Air Force Aviation Support of SOG –Kudos to 20th Special Operations Squadron pilot Dave Spencer and crewchief Woody Woodbury for preparing a power point and video presentation of the 20th SOS's mission in support of CCS. But, first...

The audience was treated to brief opening remarks by the man who is credited with coining the phrase "God's own lunatics" - referring to helicopter crews.



Renowned author, Joe Galloway of "We Were Solders Once... and Young", recalled for the group that the phrase was born during his descent into the siege of Plei Me in October '65. From there he took the audience through his journey to the follow-on battle of LZ Xray in the Ia Drang valley, and into the annals of history. Mr. Galloway, a gifted storyteller, wove his wry humor liberally throughout his portrayal of these two notable engagements that made for a fascinating tale that delighted everyone.



Following Joe Galloway, Dave and Woody tag teamed through an hour of power point and video presentations that highlighted strengths and weakness of their helicopters and armament. They made good use of well constructed power point slides to portray standard profiles for the infil and exfil of teams, and the role of gunships in support of the slicks and/or teams. In the latter stages of the CCS mission, the 20th withdrew from the insertion/extraction of teams and focused solely on providing gunship support for teams. The final twenty minutes was filled with various 8mm films shot from gunships. Again, hats off to Dave and Woody.



# SOA Video History Project and Archive Update



This year we were fortunate to receive Sully De Fontaine's OSS Congressional Gold Medal replica for the SOA Archives. On 21 March 2018 members of the Office of Strategic Services (OSS) were awarded a Congressional Gold Medal. The medal, conferred collectively, recognizes the members of the OSS for their superior service and major contributions during World War II. I would like to thank Sully for the donation of his replica medal for preservation in the SOA Archives.

Also this year the archives received a photo album of Command and Control South (CCS) Awards and Decorations ceremonies. The black and white pictures are captioned, including the date the award was given as well as the name and rank of the recipient. In the photos are a number of veterans who have already been interviewed by the Video History Project. The album

will be on display at future reunions and I encourage everyone to come by and take a look. If you are in the album and have not yet done an interview for the Video History Project please consider doing so. Also, if you have photos of your time with SOG or any of the support units please consider making copies for the SOA Archives.

The SOA Video History Project was able to conduct 11 additional interviews for the Archives. We now have over 120 interviews and our collection of historical data is now being recognized by historians at the Special Operations Command (SOCOM) and the U.S. Army Special Operations Command (USASOC) as a significant source of history on special operations during the Vietnam War.



- Eight scholarship recipients therefore are currently active and remain eligible in the program this semester. The following is an overview of recipients by class:

- The SOA's total outstanding scholarship obligation, plus required contingency at the present time is \$49,200.
- The total amount of funds in the designated scholarship account as of 31 October 2018 is as follows:
- Total Scholarship assets \$66,748.40

Additional information may be found in the current Treasurer's Report.

#### **Summary:**

- Stipend checks are \$1,000 or \$1,500 per semester for existing recipients (the recipients who received a scholarship prior to this year's recipients). For new recipients, starting with last year's awards, the total scholarship value is \$12,000 for four years, at \$1,500 per semester. The amount of funds available for new awards in any given year is based upon the amount raised from all sources, less program expenses (generally minor over the last couple of years), between the previous two SOAR's (for the 2018 academic year's awards, that means from the end of SOAR 2016 through the end of SOAR 2017), with award recommendations being limited by that amount, plus additional funds as authorized by the SOA Board, if the Board deems it necessary or desirable.
- The SOA takes a fiscally conservative approach to funding of the SOA Scholarship program. A minimum funding reserve of committed funds plus not less than 20% of the amount of funds committed to scholarships is required to be maintained in our scholarship account. These funds are kept in a Federally insured restricted account, which ensures that SOA will always have the amount of committed scholarship funds available. The amount in our reserve is occasionally increased by students not remaining in the program for one reason or another, by suspension for academic reasons, by students accelerating their academic programs, by our not awarding full four year scholarships to advanced-standing students, and by not having an "even" amount for scholarships or by not having enough applicants for the amount raised in the previous year (that has not happened in recent years!). Excess funds in the scholarship account also enables the SOA to occasionally have the flexibility to award additional scholarship money in any given year to deserving recipients beyond what was raised between the previous SOARs. The program remains fiscally sound.
















### **TAPS**

### **Endowments, Bequests and Wills**

A number of SOA members have expressed an interest in including the association as a beneficiary on their wills, or other estate planning. The SOA has been requested to provide some information on what would be necessary to accomplish this task.

First - It is imperative that the membership understand that the SOA cannot provide any legal advice, or, can any information imparted to the membership be relied upon as "legal advice or legal language sufficient for all persons, jurisdictions and circumstances." Prospective benefactors must realize that laws on descent and devise, wills, trusts and estates vary from state to state. Typically, the laws of the state in which the benefactor was domiciled govern the administration of his estate, though even this can be affected by property in other states.

Second - Any member considering the SOA as a benefactor in his will must consult an attorney or licensed estate planner to ensure compliance with the laws of his state. For example, one aspect of trust and estate laws that does vary significantly is the number of witnesses necessary for a codicil or an amendment to a will (or for the creation of an entire will itself) to be validly created and recognized by the courts and law, and whether the document must have each of the witnesses' signatures notarized. Despite those variations in law, having at least two witness signatures notarized should ensure legal validity in most cases. Nevertheless, everyone is encouraged to consult an attorney to ensure that all laws and requirements have been met in all estate planning.

Third - The Special Operations Association will accept no responsibility or liability whatsoever for harm, difficulty, or invalidity of any will or other estate planning document which is adversely affected by a member (or his family's) sole reliance on this language without consulting a qualified attorney, licensed in the state in which the member is domiciled.

Fourth - The following is provided as possible language that could be included in a will where the testator wished to leave something to the Special Operations Association:

- I. General language for a Bequest
  - A. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for its unrestricted use." Or,
  - B. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for the specific purpose of supporting (one of the following specific projects):
    - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
    - 2. The SOA Brightlight Program Fund.
    - 3. The SOA Personal Video History Project Fund.
    - 4. The SOA Warrior's Family Fund.
    - 5. The SOA General Fund.

II. Specific Bequest language:

A. "I give \_\_\_\_\_\_ (\$\$\$ amount, description of item, e.g., car, boat,

etc., legal description of real property - home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for its unrestricted use." Or,

- B. "I give \_\_\_\_\_\_\_\_\_(\$\$\$ amount, description of item, e.g., car, boat, etc., legal description of real property home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P.O. Box 335461, North Las Vegas, NV 89033, for the specific purpose (one of the following specific projects):
  - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
  - 2. The SOA Brightlight Program Fund.
  - 3. The SOA Personal Video History Project Fund.
  - 4. The SOA Warrior's Family Fund.
  - 5. The SOA General Fund.
- C. If at any time in the judgment of the governing body of the Organization, it is deemed impossible or impracticable to carry out the stated purpose of the bequest, the governing body of the Organization shall determine a purpose as near as possible to the purpose stated in the bequest.
- III. There are a multitude of other possibilities, some of which are:
  - A. Giving all or a percentage of what remains of an estate after all specific bequests having been satisfied and debts and expenses have been paid (the "rest, residue and remainder of the estate").
  - B. Give all or a portion of your estate in the event that a named beneficiary is not alive when the testator dies.
  - C. Establish a testamentary charitable trust in one's will, with a "pour-over" clause to designate which assets are to be placed in a trust with income paid to one or more beneficiaries for their lifetime, with the trust going to the veteran's organization upon the death of the last income beneficiary. Establish a trust in perpetuity in one's will, funded by some asset(s), (e.g., Life Insurance) with the beneficiary being the veteran's organization and the net income to be paid to the veteran's organization and to be disbursed by the governing body of the veteran's organization either for a specific purpose or in their sole discretion.

Note - For your planning purposes, the Special Operations Association is recognized by the Department of Defense (DOD), and by the Internal Revenue Service (IRS) as a non-profit veterans organization 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). Should you have any queries whatsoever, at anytime, always consult with your attorney.

#### THE SOA'S MACVSOG MEDAL OF HONOR PRINT

To honor and memorialize MACVSOG's Medal of Honor recipients and the men of MACVSOG **Limited Edition of 250 prints**

Certificate of Authenticity certifying that each signature on the print is original.

Each print is 20 x 24 inches and contains the names of all of MACVSOG's Medal of Honor (MOH) recipients and the original signatures of the five surviving MACVSOG MOH recipients.

Col Robert C. Howard, US Army Special Forces, CCC, Hatchet Force Rescue (Most decorated serviceman in U.S. History, submitted for the MOH three times in 13 months and appearing on the cover of the Green Beret Magazine October 1969).

NOTE: Colonel Howard passed away on 23 December 2009.

Col James P. Fleming, US Air Force 20th Special Operation Squadron's Green Hornet for rescuing RT Chisel, CCS, from imminent annihilation.

Lt Michael E. Thornton, US Navy SEAL, STOAT, for saving the life of LI Thomas Norris an MOH recipient (The only time in US History when a recipient is awarded a MOH for saving the life of another MOH recipient).

Lt Thomas R. Norris, US Navy SEAL, STOAT, for the famed 4 day "Bat 21" rescues of two downed pilots. Six months later, he sustained a near-fatal head wound in action and was rescued by his fellow Navy SEAL, Michael Thornton. SGM Jon R. Cavaiani, US Army Special Forces, CCN, for his two day defense of Radio Relay Site Hickory. He was captured during the battle and was a Prisoner of War (POW) in North Vietnam for 1 year and 8 months.

NOTE: SGM Cavaiani passed away 29 July 2014.

#### PRINT IMAGES

Upper Left: LI George Sisler, FOB 2, Hatchet Force, was Killed in Action (KIA) in Feb 1967 during a bomb damage assessment (BOA). He was the first MACVSOG Medal of Honor recipient and the first intelligence officer ever to receive the MOH.

Lower Left: Major Larry A. Thorne was lost, Missing in Action (MIA), on MACVSOG's first mission, 18 October 1965. A native of Finland, he was a recipient of the Finnish Mannerheim Cross, the equivalent of the US Medal of Honor, while serving in the Finnish Army against Russia during WWII. His remains were recovered in Laos 37 years after being declared MIA.

Right Center: On strings, during a STABO extraction in 1968, are SFC Walter Hawley, SFC Agostino Chiarello, and SFC Clifford Roberts.

During the Vietnam War there was a special breed of warrior, whose assignments were among the most dangerous. Their efforts served all the fighting men in Vietnam. They performed strategic reconnaissance. It meant high-risk duty running recon deep in enemy territory, collecting intelligence, extracting downed pilots, raiding suspected POW camps, spiking enemy supply caches and striking at the enemy from within.

We know them as U.S. Army Special Forces, SEALs, Air Commandos, Force Recon, and SAS. Beyond these honored titles, and a handful of others, participants in Special Operations defy easy description. 













#### SECRET GREEN BERET COMMANDOS IN CAMBODIA

#### About the Book

We could call this book "special operations Recon Mission Impossible." A small group of highly trained, resourceful US Special Forces (SF) men is asked to go in teams behind the enemy lines to gather intelligence on the North Vietnamese Army units that had infiltrated through Laos and Cambodia down the Ho Chi Minh trails to their secret bases inside the Cambodian border west of South Vietnam. The covert reconnaissance teams, of only two or three SF men with four or five experienced indigenous mercenaries each, were tasked to go into enemy target areas by foot or helicopter insertion. They could be 15 kilometers beyond any other friendly forces, with no artillery support. In sterile uniforms - with no insignia or identification, if they were killed or captured, their government would deny their military connection. The enemy had placed a price on their heads and had spies in their Top Secret headquarters known as SOG.

SOG had three identical recon ground units along the border areas. This book tells the history of Command and Control Detachment South (CCS). The CCS volunteer warriors and its Air Partners- the Army and Air Force helicopter transport and gunship crews who lived and fought together and sometimes died together. This is the first published history of CCS as compiled by its last living commander some forty years after they were

disbanded. It tells of the struggles and intrigue involved in SOG's development as the modern-day legacy of our modern Special Operations Commands. Forbidden to tell of their experiences for over twenty years; their After Action Reports destroyed even before they were declassified surviving veterans team together to tell how Recon men wounded averaged 100 percent; and SOG became the most highly decorated unit in Vietnam and all were awarded the Presidential Unit Citation.

#### About the Author

Lieutenant Colonel Lindsey enlisted in the Army in 1948, attaining the rank of Corporal. He was accepted in to and graduated from the US Military Academy at West Point in 1954 as a 2nd LT of Infantry. After Infantry School, he qualified as a Master Parachutist and as a Ranger. He served in various leadership and staff positions in the 11th Abn Div, the 82nd Abn Div and the 101st Abn Div. In his first Vietnam combat tour he was MACV G-3 Air Liaison Officer for the 35th Tactical Fighter Wing and flew 50 backseat missions, primarily in F-l00s. Then he went to 1st Brigade of 101st Abn Div as Asst Ops Officer and then Ops and Exec Officer of the 2/327Abn Inf Bn. On his second Vietnam tour, he was Cmdr of 2/8th Cav Bn of 1st Cav Div. Next he was Deputy Cmdr of OP-35 in MACV-SOG and then was Cmdr of Command and Control Detachment South (CCS) from January-July 1970. He is the last living Cmdr of CCS. His advance schooling included the USMA Preparatory School, a Masters degree at Indiana University, and the Command and General Staff College. He retired after 20 years from the Army in August 1972. His civilian career positions included Exec VP of an architectural and engineering firm; and president of an "Alternative Energy" firm building a Gasohol plant. He served for 12 years in the Indiana Department of Commerce as Program Manager for High Technology Development. His military awards include two Legion of Merit, two Bronze Stars, six Air Medals and the Combat Infantry Badge. Civilian awards are as a Kentucky Colonel and a Sagamore of the Wabash. He is active in local service and veterans' organizations in Carmel, IN, where he has lived with his family since 1973.
