Educational grants to vetted Active Duty, separated, and retired SOF and their families

"The Special Operations Association Foundation provides educational grants to vetted Active Duty, separated, and retired SOF and their families through the SOA's George C. Morton Memorial Scholarship Program." The SOAF provides education grants to vetted Active Duty, separated, and retired SOF and their families through the George C. Morton Memorial Scholarship Program. As of August 2018, 163 young men and women have been awarded a scholarship since the commencement of the program in 1983. The George C. Morton Memorial Scholarship Grant is awarded by the Special Operations Association (SOA) and must be used at an accredited Junior College, Community College, Technical school, or Four-year college or university for studies which will lead to an Associate Degree, a Bachelor's Degree, or a technical vocational program certificate.



**ELIGIBILITY:** A high school graduate, or a high school student anticipating graduation during the year of application, unmarried, and under the age of 21 years at the time of application. Must be a son, daughter, or grandchild, natural or adopted, of an individual who served in a Special Operations unit, and is a SOA member in "good standing". Applications are also accepted from wives and widows of Special Operators who are members of the Special Operations Association or were KIA or MIA while serving with a Special Operations unit in combat.

**APPLICATIONS:** Application packets are available from 15 September of the previous year to 15 February of the year that the grant will be awarded. The deadline for the submission of all formal applications is 15 April of the year the Grant will be awarded. 

Today I am sitting at my desk working on this piece for the PRP and thinking of those who have been lost, both during war and after. The SOA has recently experienced the loss of two more members. I'm speaking of Sully De Fontaine and Eldon Bargewell. Both were men with long military careers that together spanned many decades and armed conflicts. I was fortunate to get to know Sully through our chats during SOAR, but I only had a few short conversations with Eldon. The thing most on my mind today is that the SOA Video History Project was able to record a very good interview with Sully about his time with the British Special Operations Executive (SOE) and American Office of Strategic Services (OSS) during World War Two. Unfortunately, we were not able to record an interview with Eldon and now it is too late. The best we can hope for now is to record the remembrances of others who knew him. It is with this in mind that the Video History Project is considering a new program that will record appropriate remembrances of those who have already passed. I believe it is the bestway we have to keep the memories of those who have passed with us for the future. Not just for us, but for those who never got the opportunity to meet or serve with these men. # **POW/MIA Update**



**Latest News:** As happens all too often lately, it is likely that Congress and the Administration will fail to agree on an FY2020 budget in time to avoid the federal government entering the year operating under a Continuing Resolution. The result is that the Defense POW/MIA Accounting Agency budget will probably initially consist of \$130M assured and the remaining required \$19M being at risk.

<u>Americans Recently Accounted For</u>: On 1/15/19, DPAA posted an accounting for Roy F. Townley and Edward J. Weissenback, Air America, listed as missing on 12/27/71, in Laos. The DPAA release accounting for George L Ritter, Air America from the same incident, indicated his recovery on 12/13/17, and ID on 9/25/18. Both Townley and Weissenback were recovered late last fall and their families were notified just before Christmas, 2018. Before that, no changes in the Vietnam War statistics had been posted since October 17th when DPAA posted the names of two Vietnam War personnel now accounted for, Ritter, noted above, and LT Richard C. Lannom, USNR, TN, listed MIA on 3/1/68, NVN, recovered 12/13/17 and ID'd on 9/25/18. On 2/25/19, Defense POW/MIA Accounting Agency (DPAA) announced that Navy Reserve Journalist 3rd Class Raul A. Guerra, USN, listed as missing on 10/8/67, was accounted for. His remains were recovered on 8/15/05 and identified on 2/20/19. <u>The number still</u> missing (POW/MIA) and otherwise unaccounted-for (KIA/BNR) from the Vietnam War is now 1,589.

**History:** At the end of the Vietnam War, there were reportedly 2,583 unaccounted-for American prisoners, missing in action or killed in action/body not recovered. As of February 25, 2019, the Department of Defense lists 1,589 Americans as still missing and unaccounted-for, 90% of them in Vietnam or in areas of Cambodia and Laos where the Vietnamese operated during the war: Vietnam-1,247; Laos–288; Cambodia-48; and, Peoples Republic of China territorial waters–7. SOA and SFA join the National League of POW/MIA Families and other Veterans Service Organizations in seeking the fullest possible accounting for those still missing and repatriation of all recoverable remains. Highest priority is accounting for Americans last known alive.

**Vietnam** established comprehensive wartime and post-war processes to collect and retain information and remains; thus, unilateral efforts by them offered significant potential. Vietnam has since taken many unilateral actions that are welcome and appreciated, plus they have announced that there are no obstacles to full cooperation. Recently, Vietnam has increased implementation of commitments to provide long-sought archival records with relevant, case-related information, thanks in part to improvement of working-level efforts, but primarily due to increased bilateral relations across the board. The January 2018 SOA/SFA and League Delegations brought commitments that offered real promise for increased success. First undertaken only in northern Vietnam in 1985, joint field operations have dramatically changed and are now much more effective. Vietnamese officials are participating with greater seriousness and professionalism, achieving increased results, including both US-led Joint Excavation Teams and Vietnamese Recovery Teams, led by Vietnamese and supported by a few US personnel. This formula allows a greater number of teams to "increase the pace and scope of field operations" as requested by Vietnam since 2009, unless US budget sequestrations and reductions interfere. Due to increased military-to-military cooperation, US Navy assets are now allowed to participate in underwater survey and recovery operations.

After a rough period, joint field operations in *Laos* are now increasingly productive, even though more difficult than elsewhere. Accounting efforts had slowed due to Lao Government inflexibility, attempting to over-price payment for helicopter support and denying permission for ground transport to accessible

incident sites. Recently, Laos is showing much greater flexibility, having again authorized an increased number of US personnel in-country simultaneously, allowing ground transportation to accessible sites, and reaching agreement for contracting a private company to provide reliable, smaller-scale helicopter support to access remote sites. When helpful, Vietnamese witnesses are also allowed to participate in joint US-Lao operations. Lao officials are now approving field investigations outside the confines of scheduled DPAA field operations. A border dispute with Cambodia that was ongoing when the our delegations visited in early 2018 continues to impede recovery operations in the Lao-Cambodian disputed border area. We have urged officials in Laos and Cambodia to at least temporarily set aside their political disagreement and work trilaterally with the US to proceed on this humanitarian recovery, hoping to end the uncertainty of the families.

Two Defense Intelligence Agency (DIA) Stony Beach personnel (skilled investigators and debriefers) rotated on temporary duty in and out of Vietnam for years, collecting information via archival research and interviews of potential witnesses. DIA has now decided to permanently station one Stony Beach Vietnam specialist in Hawaii and one in Hanoi, to which Vietnam has partially agreed. Successive US Ambassadors have strongly supported this important move. And increases in bilateral military relations clearly contributed to overcoming past reluctance. One Stony Beach Lao specialist is assigned full time in Vientianne. One DIA Stony Beach Cambodia specialist works full time at the US Embassy in Phnom Penh, and research and field operations in *Cambodia* have received excellent support. It is hoped that ever-expanding bilateral relationships with Laos and Vietnam will mean positive decisions and greater flexibility to expand. Stony Beach specialists are sorely needed to augment the investigation process while witnesses are still living and able to facilitate locating incident sites for follow-up.

#### SPECIAL OPERATIONS ASSOCIATION SCHOLARSHIP GRANT PROGRAM

**FACTS:** Special Operations Association Scholarship Grants are awarded by the SOA and must be used at an accredited, Junior College, Community College, Four-year College or University for studies that can ultimately lead to a Bachelor's Degree. Each Grant is for a one year award of \$1,500 per semester not to exceed \$3,000 for the year (Applicants may reapply for subsequent years for a total of four (4) years). For institutions which are on the Quarter system, an adjustment is made such that the award does not exceed \$3,000 per year. From time to time donors will designate additional funds for other scholarship awards to our pool of applicants, and these may or may not be administered by the SOA.

**BASIC GRANT CRITERIAAND ELIGIBILITY:** An applicant must be a high school graduate or a high school student anticipating graduation during the year of application, under the age of 21 years at the time of application and is a child or grandchild, natural or legally adopted, of an individual who served in a Special Operations unit and is a member in good standing of the SOA. Such SOA member must remain a member in good standing for the duration of the scholarship awarded. A child or a grandchild of an individual who was KIA or MIA while serving in a Special Operations unit is also eligible to apply. A student who is already attending an institution of higher learning may apply, provided that they were under 21 years of age at the time that they began their studies at the institution, and have been enrolled full-time and in good standing since beginning their studies, and have not yet received a Bachelor's Degree. Eligibility is reduced by one year for each year already attended at an institution of higher learning.

**APPLICATIONS:** Application packages are available from 15 September of the previous year to 15 March of the year that the scholarships will be awarded. The postmark deadline for the submission of all formal applications is 15 April of the year the scholarships will be awarded.

**AWARDS:** On approximately 15 July of that year, selectees/recipients of a Special Operations Association Scholarship Grant will be appropriately notified by mail.

**INFORMATIONAL:** As of June 2019, 164 young men and women have been awarded scholarships since the program began in 1983.

# MG John K. Singlaub Jedburgh Award





Master Sergeant Clyde Franklin Whitmore II was selected as the recipient of the 2019 MG John K. Singlaub/Jedburgh Award. USASOC Commanding General LTG Beaudette and USASOC Command Sergeant Major Eckard, together with SOG legend SGM (Ret) Billy Waugh (SOA #005), made the presentation during the 2019 Red and Black Ball at Fort Bragg on the evening of 9 March.

The Special Operations Association created the John K. Singlaub/Jedburgh Award in recognition of, and to honor, retired U.S.

Army Maj. Gen. John K. Singlaub's courageous actions on and off the battlefield, as well as his immeasurable contributions to the United States of America, and U.S. Army Special Operations Forces specifically.

The narrative submitted recommending MSG Whitmore for the Singlaub/Jedburgh Award paints a picture of a Special Forces warrior worthy of the award. It reads in part - Over a 16-year career, MSG Whitmore has demonstrated the bravery, tenacity, thoughtful decision making, and integrity that are the hallmarks of the Special Forces Regiment and the Special Forces NCO corps.

MSGWhitmore has deployed eleven times in support of contingency operations in the CENTCOM AOR, conducting tasks ranging from counterterrorism to building partner force capacity.

MSG Whitmore spent the last two years as the Operations Sergeant on SFOD-A 5324. He led his team through three, six-month, combat deployments in support of the Defeat-ISIS campaign. Senior leaders from across the Regiment, CJTFOIR, and USCENTCOM, have sought his council for the ground truths that he consistently provides.



In 2018, MSG Whitmore's SFOD-A came under intense attack during a four-day ISIS assault against Coalition and partner force positions. MSG Whitmore demonstrated his bravery, repeatedly engaging the enemy, coordinating counterattacks, and orchestrating the defense of Coalition positions. His actions helped to minimize Coalition casualties and directly led to saving the lives of members of the Coalition.

MSG Whitmore's focus on NCO development, building warfighting capability, and sound council are without equal. Despite the grueling OPTEMPO of the past two years, he pushed his team to cross-train, develop new combat skills, and become adaptive,

innovative thinkers. His tireless actions resulted in a Detachment ready for the perils of combat.

He fully embodies the ARSOF promise to "Protect the Nation, Without Fear, Without Fail, and Without Equal".





# **Standing Rules of Order**

### Special Operations Association Reunion XLIII Annual General Member Meeting Standing Rules of Order

#### **Preamble:**

The Board of Directors has created the following Standing Rules of Order in accordance with the directions and guidelines established in Chapter XIX of Roberts Rules of Order Newly Revised (RRNR).

The purpose of these Standing Rules of Order are to assure members' rights are fully protected, simplify what otherwise are sometimes confusing and contradictory Parliamentary Procedure options, establish order, and to capture the exact wording of proposed Topics of Discussion (TODs), Resolutions and Motions for the record.

These Standing Rules require approval by the General Members before they will be implemented and adhered to for this GMM. These Standing Rules of Order are temporary and apply to this one single GMM only. Their authority ceases on the adjournment of the GMM.

We ask every General Member to read these proposed Standing Rules and to approve them with his vote.

Admission into the General Member Meeting room requires all members to wear or prominently display the Badge/Name tag issued by the Secretary/Registration Committee. General Members will be seated in the area designated by the Sergeants-at-Arms for "voting" members.

The Secretary, directly after the opening ceremonies, shall report the number of General Members registered at this year's SOAR and/or exclusively for the GMM and the number of those currently present in the meeting room. The number present at the beginning of the business meeting shall be the number used to determine if the SOA's quorum requirements have been met per Article VII Section C of the Bylaws. If the quorum requirement is met, the number of members reported present shall be the base number for determining a majority for all votes conducted during this GMM.

All voting will be by physical count of hands or ballots. When voting, members are requested to raise their RIGHT hand over their heads in order that the Sergeants-at-Arms can facilitate a proper count.

General Members who desire to present a Topic of Discussion (TOD), Resolution, or Motion from the floor that was not previously submitted to the Secretary per SOA Bylaws Article VII Section E must first submit a legibly written or typed copy to the Secretary prior to the opening the GMM but no later than the opening of New Business. If the request is in compliance with the Bylaws it will be added to the agenda under New Business in the order it was received by the Secretary.

At the appropriate time on the Agenda, the Secretary will request the Member who desires to open a TOD, make a Resolution, or Motion to rise and request their TOD, Resolution, or Motion to be read by the Secretary. In lieu of the President stating the question, the Secretary will read the TOD, Resolution, or Motion as presented and entered into the record at which time the Chair

will call for a Second. If a Second is made, the Chair will then acknowledge the originating member who may then speak as in Rules 5 & 6, and, if appropriate, a vote will follow.

Two (2) microphones are available to members during debate. Any person wishing to speak during debate must do so from one of the microphones or he will not be recognized by the Chair. As designated, one microphone will be for those members who wish to speak in support of the question and the other for those opposed. When recognized, the member is requested to state his name and membership number prior to speaking.

Members are limited to two (2) three (3) minute periods of debate per question and a member will not be permitted to speak a second time until all other members who wish to speak to the question have spoken once. Total time for Debate will be limited to 12 minutes per question.

General Members may make a motion to set aside Rule 5 and substitute new requirements which will become the temporary Rule for that specific TOD, Resolution, or Motion if passed by a 2/3rds majority (as is detailed in RRNR, page 253) of the quorum requirement as defined in Rule 2.

The Chair will rule out of order TOD(s), Resolution(s), or Motion(s) and not approve for discussion, debate, and/or vote those subjects that violate the SOA Bylaws and those where the SOA Attorney and/or Attorneys for Association's Insurance Carrier have directed they not to be discussed beyond what has been previously posted by the BOD.

General Members may make a motion to set aside Rule 7 and if seconded and passed with a 2/3rds majority (ref. RRNR, page 253) of the quorum as defined in Rule 1. Prior to the vote, the Chair will provide the reason for his ruling, and if appropriate, either read or pass out copies of the board's posting(s). If the topic is one which the SOA's Lawyer and/or Insurance Company's Lawyer(s) has stated should not be discussed the Chair and the BOD will not answer questions or become involved in the debate. They will, however, participate in the vote if there is one.

General Members may appeal the President's rulings as stipulated in Section 24, pages 247-252 of RRNR. As stated on page 252, a majority or tie vote sustains the decision of the President. The President is authorized to vote in order to create a majority or tie decision.

The Chair will rule on all Parliamentary Questions in accordance with the authority granted in RRNR (pages 432 - 435 and elsewhere). At his discretion, as defined on page 243, the President may temporarily suspend the meeting, stand at ease, to obtain confidential advice from the Parliamentarian or other accepted parliamentary authority prior to making his ruling. Special attention is to be placed on "Decorum" specified on pages 379 - 3 defined 84. A professional Registered Parliamentarian, (Mrs. Solveiga Unger) has been retained by the SOA Board to assist the President in the interpretation and application of parliamentary procedure.

All members and guests are required to turn off cell phones and pagers during the conduct of the General Member Meeting. Cell phones may be used to record the meeting if the ring and buzzer notifications are turned off. The use of recording devices is authorized.



Any prospective Advertiser desiring to place an Advertisement in either the AAR or PRP must ensure that the Advertisement is in "good taste", "not of questionable moral value", and "will not reflect negatively on the SOA, or any of its members".
- **c.** <u>SOA RESPONSIBLE AGENT:</u> The Chairman, SOA Fund Raising Committee is the responsible "Agent", acting on behalf of the SOA Board of Officers and Directors in all matters relating to acceptance, or rejection of prospective Vendor/Exhibitor requests, or Placement of Advertisements in either SOA annual publications.
- **d.** <u>SOA BOARD:</u> Finally, in the event a prospective Vendor/Exhibitor or Advertiser does not agree with the decision of the Chairman, SOA Fund Raising Committee, the SOA Board is the final arbitrator. Anything that it deems is inappropriate will not be allowed for display or publication.

# **Endowments, Bequests and Wills**

A number of SOA members have expressed an interest in including the association as a beneficiary on their wills, or other estate planning. The SOA has been requested to provide some information on what would be necessary to accomplish this task.

First - It is imperative that the membership understand that the SOA cannot provide any legal advice, or, can any information imparted to the membership be relied upon as "legal advice or legal language sufficient for all persons, jurisdictions and circumstances." Prospective benefactors must realize that laws on descent and devise, wills, trusts and estates vary from state to state. Typically, the laws of the state in which the benefactor was domiciled govern the administration of his estate, though even this can be affected by property in other states.

Second - Any member considering the SOA as a benefactor in his will must consult an attorney or licensed estate planner to ensure compliance with the laws of his state. For example, one aspect of trust and estate laws that does vary significantly is the number of witnesses necessary for a codicil or an amendment to a will (or for the creation of an entire will itself) to be validly created and recognized by the courts and law, and whether the document must have each of the witnesses' signatures notarized. Despite those variations in law, having at least two witness signatures notarized should ensure legal validity in most cases. Nevertheless, everyone is encouraged to consult an attorney to ensure that all laws and requirements have been met in all estate planning.

Third - The Special Operations Association will accept no responsibility or liability whatsoever for harm, difficulty, or invalidity of any will or other estate planning document which is adversely affected by a member (or his family's) sole reliance on this language without consulting a qualified attorney, licensed in the state in which the member is domiciled.

Fourth - The following is provided as possible language that could be included in a will where the testator wished to leave something to the Special Operations Association:

- I. General language for a Bequest
  - A. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for its unrestricted use." Or,
  - B. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P.O. Box 335461, North Las Vegas, NV 89033, for the specific purpose of supporting (one of the following specific projects):
    - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
    - 2. The SOA Brightlight Program Fund.
    - 3. The SOA Personal Video History Project Fund.
    - 4. The SOA Warrior's Family Fund.
    - 5. The SOA General Fund.

- II. Specific Bequest language:
  - A. "I give \_\_\_\_\_\_ (\$\$\$ amount, description of item, e.g., car, boat, etc., legal description of real property home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for its unrestricted use." Or,
  - B. "I give \_\_\_\_\_\_ (\$\$\$ amount, description of item, e.g., car, boat, etc., legal description of real property home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Linda M. Leavitt, SOA Administrator, P. O. Box 335461, North Las Vegas, NV 89033, for the specific purpose (one of the following specific projects):
    - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
    - 2. The SOA Brightlight Program Fund.
    - 3. The SOA Personal Video History Project Fund.
    - 4. The SOA Warrior's Family Fund.
    - 5. The SOA General Fund.
  - C. If at any time in the judgment of the governing body of the Organization, it is deemed impossible or impracticable to carry out the stated purpose of the bequest, the governing body of the Organization shall determine a purpose as near as possible to the purpose stated in the bequest.
- III. There are a multitude of other possibilities, some of which are:
  - A. Giving all or a percentage of what remains of an estate after all specific bequests having been satisfied and debts and expenses have been paid (the "rest, residue and remainder of the estate").
  - B. Give all or a portion of your estate in the event that a named beneficiary is not alive when the testator dies.
  - C. Establish a testamentary charitable trust in one's will, with a "pour-over" clause to designate which assets are to be placed in a trust with income paid to one or more beneficiaries for their lifetime, with the trust going to the veteran's organization upon the death of the last income beneficiary. Establish a trust in perpetuity in one's will, funded by some asset(s), (e.g., Life Insurance) with the beneficiary being the veteran's organization and the net income to be paid to the veteran's organization and to be disbursed by the governing body of the veteran's organization either for a specific purpose or in their sole discretion.

Note - For your planning purposes, the Special Operations Association is recognized by the Department of Defense (DOD), and by the Internal Revenue Service (IRS) as a non-profit veterans organization 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). Should you have any queries whatsoever, at anytime, always consult with your attorney.

### About the Book

We could call this book "special operations Recon Mission Impossible." A small group of highly trained, resourceful US Special Forces (SF) men is asked to go in teams behind the enemy lines to gather intelligence on the North Vietnamese Army units that had infiltrated through Laos and Cambodia down the Ho Chi Minh trails to their secret bases inside the Cambodian border west of South Vietnam. The covert reconnaissance teams, of only two or three SF men with four or five experienced indigenous mercenaries each, were tasked to go into enemy target areas by foot or helicopter insertion. They could be 15 kilometers beyond any other friendly forces, with no artillery support. In sterile uniforms - with no insignia or identification, if they were killed or captured, their government would deny their military connection. The enemy had placed a price on their heads and had spies in their Top Secret headquarters known as SOG.

SOG had three identical recon ground units along the border areas. This book tells the history of Command and Control Detachment South (CCS). The CCS volunteer warriors and its Air Partners- the Army and Air Force helicopter transport and gunship crews who lived and fought together and sometimes died together. This is the first published history of CCS as compiled by its last living commander some forty years after they were

disbanded. It tells of the struggles and intrigue involved in SOG's development as the modern- day legacy of our modern Special Operations Commands. Forbidden to tell of their experiences for over twenty years; their After Action Reports destroyed even before they were declassified surviving veterans team together to tell how Recon men wounded averaged 100 percent; and SOG became the most highly decorated unit in Vietnam and all were awarded the Presidential Unit Citation.

### About the Author

Lieutenant Colonel Lindsey enlisted in the Army in 1948, attaining the rank of Corporal. He was accepted in to and graduated from the US Military Academy at West Point in 1954 as a 2nd LT of Infantry. After Infantry School, he qualified as a Master Parachutist and as a Ranger. He served in various leadership and staff positions in the 11th Abn Div, the 82nd Abn Div and the 101st Abn Div. In his first Vietnam combat tour he was MACV G-3 Air Liaison Officer for the 35th Tactical Fighter Wing and flew 50 backseat missions, primarily in F-100s. Then he went to 1st Brigade of 101st Abn Div as Asst Ops Officer and then Ops and Exec Officer of the 2/327Abn Inf Bn. On his second Vietnam tour, he was Cmdr of 2/8th Cav Bn of 1st Cav Div. Next he was Deputy Cmdr of OP-35 in MACV-SOG and then was Cmdr of Command and Control Detachment South (CCS) from January-July 1970. He is the last living Cmdr of CCS. His advance schooling included the USMA Preparatory School, a Masters degree at Indiana University, and the Command and General Staff College. He retired after 20 years from the Army in August 1972. His civilian career positions included Exec VP of an architectural and engineering firm; and president of an "Alternative Energy" firm building a Gasohol plant. He served for 12 years in the Indiana Department of Commerce as Program Manager for High Technology Development. His military awards include two Legion of Merit, two Bronze Stars, six Air Medals and the Combat Infantry Badge. Civilian awards are as a Kentucky Colonel and a Sagamore of the Wabash. He is active in local service and veterans' organizations in Carmel, IN, where he has lived with his family since 1973.

Col Robert C. Howard, US Army Special Forces, CCC, Hatchet Force Rescue (Most decorated serviceman in U.S. History, submitted for the MOH three times in 13 months and appearing on the cover of the Green Beret Magazine October 1969).

#### NOTE: Colonel Howard passed away on 23 December 2009.

Col James P. Fleming, US Air Force 20th Special Operation Squadron's Green Hornet for rescuing RT Chisel, CCS, from imminent annihilation.

Lt Michael E. Thornton, US Navy SEAL, STOAT, for saving the life of Lt Thomas Norris an MOH recipient (The only time in US History when a recipient is awarded a MOH for saving the life of another MOH recipient).

Lt Thomas R. Norris, US Navy SEAL, STOAT, for the famed 4 day "Bat 21" rescues of two downed pilots. Six months later, he sustained a near-fatal head wound in action and was rescued by his fellow Navy SEAL, Michael Thornton. SGM Jon R. Cavaiani, US Army Special Forces, CCN, for his two day defense of Radio Relay Site Hickory. He was captured during the battle and was a Prisoner of War (POW) in North Vietnam for 1 year and 8 months. NOTE: SGM Cavaiani passed away 29 July 2014.

#### PRINT IMAGES

Upper Left: Lt George Sisler, FOB 2, Hatchet Force, was Killed in Action (KIA) in Feb 1967 during a bomb damage assessment (BOA). He was the first MACVSOG Medal of Honor recipient and the first intelligence officer ever to receive the MOH.

Lower Left: Major Larry A. Thorne was lost, Missing in Action (MIA), on MACVSOG's first mission, 18 October 1965. A native of Finland, he was a recipient of the Finnish Mannerheim Cross, the equivalent of the US Medal of Honor, while serving in the Finnish Army against Russia during WWII. His remains were recovered in Laos 37 years after being declared MIA.

# In Memoriam Col. Sully de Fontaine



COL (R) Sully de Fontaine passed away on 22 April 2019 in Las Vegas, NV. He was one of the originals and a founding member of the Special Forces Association. He was a member of Chapter 51 in Las Vegas. He was born in Brussels, Belgium to French parents. He began his Special Operations career in 1943 when he joined the Office of Strategic Intelligence (OSS). He was trained by the Special Operations Executive (SOE) and the British Special Air Service. In 1944 he parachuted into occupied France to rescue downed pilots. After the liberation of France, he was attached to the OSS-SOE based in Belgium. He attended French, Belgium and British Military

Schools as well as earning a Bachelor of Arts degree in philosophy. In 1956 he was sent TDY to the 10<sup>th</sup> Special Forces Group in Germany during the Hungarian uprising. He volunteered for Special Forces and completed the Qualification Course in 1957. He was assigned to the Special Warfare School at Fort Bragg instructing in Soviet Intelligence, Escape and Evasion, and Counter Guerilla Warfare. In 1959 as a 1LT he was assigned to the 10<sup>th</sup> Special Forces Group and became the Group's Security Officer. He led an operation into the Congo to evacuate over 200 stranded missionaries from remote jungle areas. Based on his operations in Africa he authored "Slaver's Wheel," which is still studied today. In 1962 he deployed to Algeria serving with French Airborne as an observer during the Algerian War. In 1963 he was assigned to the 5<sup>th</sup> Special Forces Group and deployed with them to Vietnam commanding an ODA. In 1965 he commanded an Operational Detachment "B" in the Delta region. He then volunteered for MACV SOG.

In 1966 COL de Fontaine became a Military Police Officer and commanded a CID unit in France. In 1968 he returned to Vietnam as the Officer in Charge of the Special Branch of the CID and afterwards he transferred to the Criminal Investigation Agency in Washington, DC. From 1971 to 1973 he served as the Provost Marshall of the 1<sup>st</sup> Armored Division in Germany. In 1973 he was assigned as the Field Element Commander of the Joint Casualty Recovery Center (JCRC).

Sully retired in 1976 and continued utilizing the skills he developed in the Military. His many occupations included; Special Agent – Western Bureau of Investigations; Senior Agent – Nevada State Gaming Control Board, Senior VP Corporate Security – United Gaming, Inc; President – International Consulting Agency, Inc; Corporate Investigator – Park Place Entertainment, Inc. and Director of Investigations – Venetian Macau, LTD, China.

His numerous awards and decorations include: Legion of Merit w/OLC, Bronze Star w/V, Purple Heart w/OLC, Meritorious Service Medal, Joint Service Commendation Medal w/V, Armed Forces Expeditionary Medal, Combat Infantryman's Badge, Master Parachutist Badge and British Special Air Service Parachutist Badge.

Eldon Bargewell (Retired) MG Bargewell was born in Tacoma, Washington. Enlisting in the U.S. Army in 1967, he completed the Special Forces Qualifcation Course in 1968. MG Bargewell has served in the following Special Forces and Special Operations units: the 5th Special Forces Group (Airborne) (SFG(A)); 6th SFG(A); 7th SFG(A); and 10th SFG(A); Co B (Ranger (RGR)) 75th INF (Long Range Reconnaissance Patrol (LRRP)) Company; 2nd BN (Ranger) 75th INF; Military Assistance Command - Vietnam Studies and Operations Group Command Control North (MACV-SOG CCN); 1st Special Operations Forces Operational Detachment – Delta (SFOD-D): Special Operations Command-Europe (SOCEUR); Joint Special Operations Command (JSOC); and US Special Operations Command (USSOCOM). In September 1968, he was assigned to Reconnaissance Company, MACV-SOG CCN. During his two tours in SOG as a Non-Commissioned Officer Team Leader, Bargewell conducted

over 25 recon, direct action and team recovery missions into Laos and North Viet Nam. During a cross-border mission on September 27, 1971 where his team was ambushed by a greater enemy force, his actions in saving his team and getting them to safety even though he was gravely wounded earned him the Distinguished Service Cross.

Shortly after returning from Vietnam in 1972, MG Bargewell attended Infantry Officers' Candidate School (OCS) which he graduated as the Leadership Honor Graduate of OCS class 3-73 in April 1973. During his subsequent 33 years, he commanded special operations units from team to Special Operations Command level in Cambodia, Laos, North Viet Nam, the Middle East, El

Salvador, Operation JUST CAUSE (Panama), DESERT STORM (Iraq), RESTORE DEMOCRACY and ALLIED FORCE (Bosnia/Kosovo); and as Director of Operations for Operations Restore Hope (Haiti), Enduring Freedom-NATO (Afghanistan) and Iraqi Freedom (Iraq).

His frst assignment was with Co B (RGR) 75th INF (LRRP) at Ft. Lewis, Washington whose wartime mission was to provide reconnaissance teams in support of 7th Corp in the Fulda Gap area, Germany. MG Bargewell served in multiple assignments with the unit including as a Patrol Platoon Leader, acting Company Commander (Cmdr) followed by duty as a Rifle Platoon Leader and Executive Officer. He also served as the Aide-de-Camp to the Assistant Deputy Commander 9th Infantry Division (ID). Upon promotion to Captain he was assigned to the 3rd Brigade, 9th ID, where he served as S-3 Air and Rifle Company Cmdr in 2d Battalion, 47th Infantry. Following a brief assignment as Infantry Branch Representative at Ft. Benning, MG Bargewell was selected for assignment to 1st SFOD-D in 1981 where he served as Operations Officer, Squadron Executive Officer, Troop and Squadron Commander (twice), Deputy

Commander, and finally, Cmdr. From 1993 to 1996 Bargewell was assigned to JSOC as the Director of Operations J-3. Upon selection to Brigadier General in 1998 he was assigned as the Commanding General, SOCEUR in Stuttgart, Germany with the mission to provide trained and equipped Army, Navy and Air Force Special Operations units for employment in Africa and Europe, espe- cially Bosnia and Kosovo. While commanding the Joint Special Operations Task Force (JSOTF) Noble Anvil during Operation ALLIED FORCE in Serbia, Bargewell pro- vided Combat Search and Rescue forces. His JSOTF is credited with the rescues of two shot down USAF pilots as well as the conduct of several other operations.

From 2000 to 2001, he served as the Assistant Chief of Staff for Operations, Stabilization Force Headquarters (SFOR),

Sarajevo, Bosnia, responsible for operational actions against Persons Indicted for War Crimes. Returning stateside in 2001, for the next two years, MG Bargewell was the Director of the Center for Special Operations, Plans, and Policy, USSOCOM, Florida before being assigned as the Deputy Chief of Staff for Operations at Allied Joint Force Command (NATO) - Brunssum, Netherlands for the next two years. During this assignment, he also served as the CG for the Division size NATO RESPONSE FORCE and was the senior US Military Representative to the US Ambassador in the Netherlands. MG Bargewell's final assignment on active duty was as the Director of Strategic Operations at HQ's Multi-National Force-Iraq in Baghdad (2005-2006).MG Bargewell's military decorations include the Distinguished Service Cross, Defense Distinguished Service Medal, Army Distinguished Service Medal, Defense Superior Service Medal (5), Legion of Merit, Bronze Star Medal for valor (3), Bronze Star Medal for service (3), Purple Heart (4), Defense Meritorious Service Medal, Army Meritorious Service Medal, Air Medal, Army Commendation Medal for Valor, Army Commendation Medal for service, Army Good Conduct Medal, National Defense Service Medal (2), Armed Forces Expeditionary Medal w/Bronze Arrowhead, Vietnam Service Medal (7), Southwest Asia Service Medal, Armed Forces Service Medal, Humanitarian Service Medal, NATO Medal(3), NCO Professional Development Ribbon, Army Service Ribbon, GWOT Service Medal, Overseas Service Ribbon, Republic of Vietnam Campaign Medal, Kuwait Liberation Medal, Presidential Unit Citation (MACV SOG-VN), Joint Meritorious Unit Citation (2), Valorous Unit Award, Meritorious Unit Commendation, Republic of Vietnam Gallantry Cross Unit Citation, Republic of Vietnam Civil Actions Unit Citation, French Service Medal (Ex-Yugoslavia), Combat Infantry Badge, Master Parachutists Badge, Special Forces Tab, Ranger Tab, Military Free Fall Badge. Vietnamese HALO badge, Vietnamese, German, and Thai Parachute Badges. MG Bargewell is also the recipient of the Colonel Aaron Bank award (2007), the Greater DC SOF Old and Bold Mountain Man award (2009), and the USSOCOM Bull Simons Award (2010). He is a member of Infantry Officers Candidate Hall of Fame (1997) and an enlisted Honor Graduate Ranger School (1970).

### The Special Operations Association Vietnam Tribute Pistol

A Handsomely Decorated Browning Hi-Power Pistol

During the Vietnam War there was a special breed of warrior, whose assignments were among the most dangerous. Their efforts served all the fighting men in Vietnam. They performed strategic reconnaissance. It meant high-risk duty running recon deep in enemy territory, collecting intelligence, extracting downed pilots, raiding suspected POW camps, spiking enemy supply caches and striking at the enemy from within.

We know them as U.S. Army Special Forces, SEALs, Air Commandos, Force Recon, and SAS. Beyond these honored titles, and a handful of others, participants in Special Operations defy easy description. Today America Remembers is proud to honor all of these heroic warriors who served in Southeast Asia with the Special Operations Association Vietnam Tribute Pistol – a handsome Tribute issued on a legendary military sidearm, the Browning Hi-Power pistol.

From launch sites inside Vietnam, such as Kham Duc, Phu Bai, and others, members of the Studies and Observations Group (SOG) served covertly behind enemy lines, often in very dangerous situations and in difficult terrain. In fact, the Browning Hi-Power was so respected, this classic military firearm was used for special presentations to recognize outstanding accomplishments. Designated the "Reconnaissance Team Leader Special Recognition Award," and called the "Silver Pistol," this unique presentation was awarded to a very limited number of individuals during the Vietnam War.

The Special Operations Association Vietnam Tribute from America Remembers features dramatic and powerful artwork honoring those who served in Southeast Asia.
